## What it is about

Fyooz is a social money pioneer with proof of concept and notoriety. Now that Fyooz resonates with celebrities, it is time for some adjustments, including: allowing FYZ holders to participate in decision making and getting exclusive benefits by participating in the “Fyooz Circle”. The functionality as a payment token and transaction currency will remain.

## How it works

As an owner of FYZ Coins you get the exclusive right to become a member of the "Fyooz Circle". Fyooz has created three Circles in the form of Telegram groups. The three Circles require different amounts of FYZ to be held in order to be admitted. On the other hand, members receive different benefits and rights.

To participate in the «The Club», you need to hold 1,000 Fyooz Coins (FYZ). To gain admittance into the «The Jury» and thus gain voting rights, the amount is 10,000 FYZ. In addition, there will be a «Hall of Fame» for everyone who holds 100,000 FYZ, which entitles members to submit proposals.

## Fyooz Circles



### The Club

Everyone holding at least 1,000 FYZ is entitled to enter “The Club”. With this, the holders show their involvement in building the Fyooz platform and commitment to the evolution of a social money economy. Information will be shared and discussed before it goes anywhere else. Members have the chance to get airdrops and NFTs.

### The Jury

Anyone who holds 10,000 FYZ automatically becomes a member of “The Jury”. This not only ensures that you are more involved in the business and have the chance to get even more exclusive experiences, but also that you have additional rights. Members of “The Jury” vote on proposals that are put to a vote by the “Hall of Fame” or the Fyooz Team.

### Hall of Fame

In the “Hall of Fame” you are automatically included if you have 100,000 FYZ on a single wallet. In addition to the rights and benefits of the Club and Jury circles, the members of the “Hall of Fame” receive the right to formulate proposals and thus decisively contribute to Fyooz. Members of this group can introduce people whose admission will be voted on. These can be stars, consultants, partners or selected community members who have shown commitment to the project.

## Governance Tools

The “Fyooz Circle” is organized on **Telegram**, using **Collab.land** to govern access rights to the “Fyooz circles”. That means you will automatically be removed from a Fyooz Forum group if you sell FYZ coins. Proposals are created and submitted off-chain via **Snapshot**.

## Fyooz Circle access

It is possible that not only FYZ, but also other coins, for example, Star Tokens or partner coins from Fyooz, entitle to get access to the Fyooz Circle.

## Fyooz Team Rights

Even in times of progressive decentralization, a core team is important for driving the project. Therefore, the team has the right to put proposals to a vote, and – since the team is ultimately responsible for the implementation – also to veto proposals from the “Hall of Fame” as a last resort.

## Summary

With the introduction of this access, voting, and governance system, Fyooz rewards loyalty and gives investors, stars, and advisors the opportunity to actively participate in further development. Moreover, membership in one of the Fyooz Forums will allow Fyooz holders access to information and benefits. The changes will come into effect as of February 1st, 2021.
